Among the types of Personal Data that this Application collects, by itself or through third parties, there are: Usage Data; Tracker; Universally unique identifier (UUID); various types of Data; session statistics.

In cases where this Application specifically states that some Data is not mandatory, Users are free not to communicate this Data without consequences to the availability or the functioning of the Service.

Mode and place of processing the Data

Methods of processing

Legal basis of processing

The Owner may process Personal Data relating to Users if one of the following applies:

- Users have given their consent for one or more specific purposes.
